Crawford Fund e-Mentoring Description and Guidelines June 2020

Background

Given that COVID-19 has stopped international travel, the Crawford Fund is developing an e-mentoring program to ensure that we continue to help develop the technical and organisational skills and expertise of agricultural researchers, scientists and policy makers in developing countries.

This program will link mentees in developing countries with experienced Australians. We envisage that interaction between mentor and mentee will take place by a mix of email, phone and/or internet conferencing.

The program will build on the successful outcomes of our long term existing <u>Mentoring Program</u>, which has seen face-to-face interaction in overseas countries, also backed up by electronic contact.

We are currently (June-July, 2020) calling for expressions of interest from possible mentors and will be seeking potential mentees via existing alumni networks from July.

The Crawford Fund reserves the right to select who takes part in the program.

Expectations of mentors and mentees

- Mentoring roles will operate anywhere along the agricultural development value chain (including natural resources management, fisheries, forestry), including research, extension, management and supporting activities. There is an expectation that some mentees will be interested in cross cutting issues such as climate-smart agriculture, sustainable intensification etc.
- Mentors will be experienced research scientists or managers, still current in their fields and able to share their knowledge with developing country scientists and managers and their institutions.
- Mentoring activities will vary in terms of their frequency and type of contribution and could include assisting with delivery of high-quality laboratory results, planning field surveys, biosecurity issues, animal management, scientific methods, statistical analyses, etc.
- Mentors will establish regular contact (via electronic media) with their mentees to assist them with new and emerging opportunities and issues during the course of their mentoring role.
- Mentors and mentees will be encouraged to build ongoing relationships between Australian institutions and the overseas institutions where mentees work.
- Mentors will work with Crawford Fund and ACIAR in ensuring continual improvement in the training and learning approaches they deploy.
- Mentors will seek to advance gender equity by specifically looking to increase the capacity of female researchers, and to leverage the experience of senior female mentors.

- The Crawford Fund will provide a small honorarium to mentors to a maximum of \$250 per annum to cover their input to the program. In cases of hardship, the Crawford Fund may also assist mentees with direct costs associated with appropriate software and network access to help them participate.
- The Crawford Fund would expect short reports from the mentor and mentee on a six-monthly basis, and at the end of any relationship if shorter than a year.
